A Resolution for Comprehensive Conservation Funding

Whereas, the Pennsylvania Constitution guarantees the people of the Commonwealth the right to clean air, pure water, and the preservation of the natural, scenic, historic, and aesthetic values of the environment.

Whereas, Pennsylvania is a state rich in special natural, scenic, and historic places which help to define who we are and which are valued and used by citizens and visitors of the Commonwealth.

Whereas, citizens, non-profit organizations, local and state governments, and industries throughout Pennsylvania have emerged as nationwide leaders in the holistic watershed approach to natural resource management.

Whereas, Pennsylvanians are embracing environmental management strategies that are built on partnerships, recognizing the interconnected relationships among urban, suburban, and rural natural resources and populations and between problems and solutions.

Whereas, **Growing Greener** has had significant successes, including watershed-based assessment, planning, and restoration; abandoned mine land remediation; reduction of nutrient and sediment loading to waterways; wetland, riparian, and other habitat protection; enhancement of community infrastructure; and farmland preservation.

Whereas, the demand for **Growing Greener** funds has far exceeded available resources, deserving projects remain unfunded, and the **Growing Greener** program will expire on June 30, 2004, at the end of fiscal year 2003-2004.

Whereas, Pennsylvania needs comprehensive, permanent funding for water, land, and wildlife conservation to promote responsible natural resource management; enhance urban, suburban, and rural environmental quality; support healthy fish and wildlife populations; improve public health; build sustainable economies and strong, attractive communities; protect fertile farmland and important open spaces; and create and maintain adequate recreational opportunities and accompanying infrastructure.

Resolved, that the undersigned citizen and/or organization of the Commonwealth of Pennsylvania supports the establishment of a permanent state funding stream for programs in the spirit of **Growing Greener** to protect, enhance, and restore Pennsylvania's natural resources and communities without jeopardizing successful existing environmental programs.

Please help Pennsylvania get its fair share.

The federal legislation (SMCRA) designed to reclaim abandoned mine lands is falling short of its promise. Money earmarked for reclamation is being collected but not being spent. Much of the money being spent is going to states needing it least. Meanwhile, Pennsylvania and other eastern coal producing states have a multitude of serious abandoned mine problems going unaddressed. The President and Congress are using the Abandoned Mine Land Fund to help balance the budget instead of using it as intended by funding abandoned mine reclamation. So far, almost \$1.5 billion has been withheld from the states.

Pennsylvania alone has approximately \$15 billion worth of environmental problems caused by mining practices of the past. Current and future generations of taxpayers have been left with the bill of fixing these problems.

The resolution on the opposite page requests a release of the Abandoned Mine Land Fund and a proportionate distribution to those states needing it most. It requests that the SMCRA legislation be renewed past its 2004 sunset date. Please help Pennsylvania get its fair share by endorsing the resolution. Thank you.

Pennsylvania's Resolution for Abandoned Mine Reclamation

Whereas, substantial coal mining has occurred in Pennsylvania for over 125 years in part providing the fuel for the United States industrial revolution and for support of two World War efforts, and the industry has been a significant employer of our citizens for most of those years;

Whereas, the Surface Mine Control and Reclamation Act of 1977 (SMCRA) imposed on coal operators a fee of 35 cents per ton on surface mined coal and 15 cents per ton on underground mined coal.

Whereas, those fees were sent to the Secretary of Interior for deposit in the Abandoned Mine Land (AML) Fund for the purpose of paying for the reclamation and remediation of lands mined prior to 1977.

Whereas, even though those fees were to be spent for reclamation and remediation of lands mined prior to 1977, over \$1.3 billion collected and earmarked for this work remains unspent in the US Treasury as of September 30, 2001.

Whereas, Pennsylvania has an estimated cleanup cost of \$15 billion with over 3,500 miles of streams impacted with heavy metals from mine drainage, such as iron, aluminum and manganese, that can be toxic to human health and has 250,000 acres of scarred landscape containing dangerous hazards such as highwalls and water filled pits.

Whereas, the people in Pennsylvania have the right to safe homes, viable communities, clean water free from abandoned mine drainage.

Whereas, this fund is set to expire in the year 2004 without its reauthorization by Congress.

Whereas, many jobs will be created with the increased spending of these fund.

Resolved that the undersigned watershed association/ interested citizen supports the initiative to reclaim more old mine sites, to clean up more water resources of the Commonwealth of Pennsylvania, and to provide more jobs for the citizens of the Commonwealth and also urges Congress through the Secretary of the Interior to reauthorize the Abandoned Mine Land Trust Fund and to increase the obligation of monies in the Trust Fund to the state for the purposes for which they were collected.

CONFERENCE EXHIBITOR REGISTRATION


