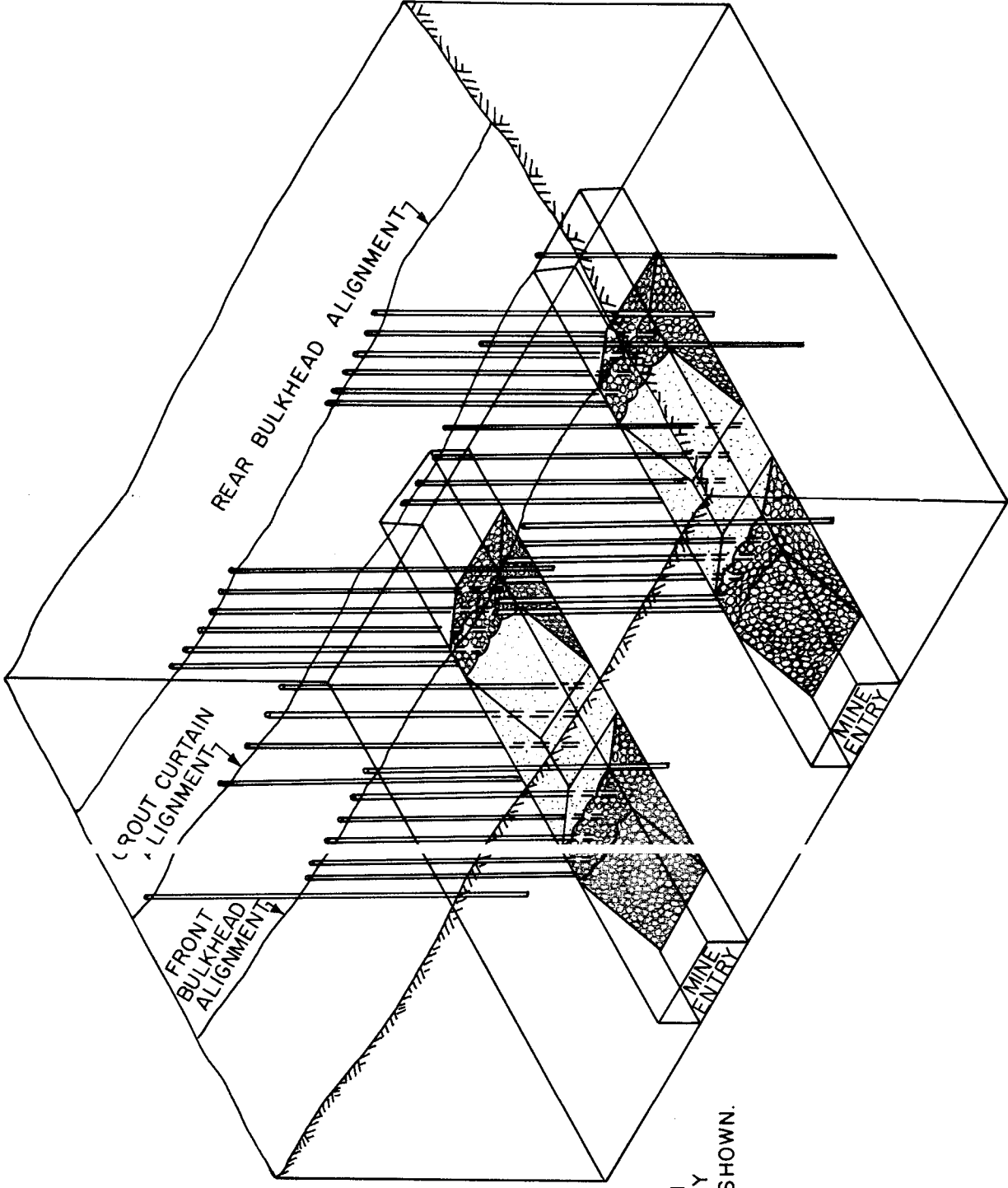
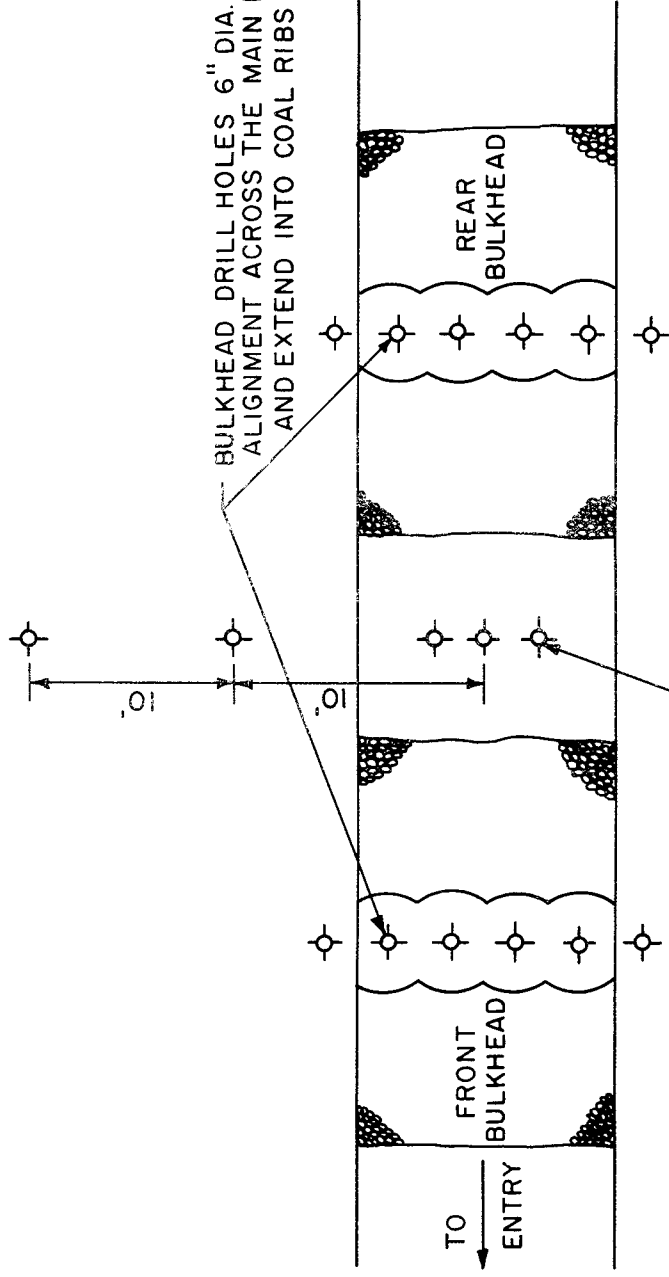

INJECTION HOLES FOR CENTER PLUG. NO. OF HOLES TO BE DETERMINED IN THE FIELD.

DRILL HOLES FOR GROUT CURTAIN, 3" DIA. ON 10' CENTERS ON ALIGNMENT PARALLEL TO AND APPROX. MIDWAY BETWEEN THE FRONT AND REAR BULKHEAD TO BE EXTENDED A MINIMUM OF 50' ON BOTH SIDES OF MINE ENTRY.
